What is the Comprehensive Plan? Is it really like watching grass grow? No, it is Much more!!

County government policy that helps guide public and private activities as they relate to land use and resource use. As the means to carry out this purpose, the Plan is the County's most important policy document. It establishes the blueprint for future decisions regarding resource protection, land use and development, transportation systems, public facilities and utilities, economic development, housing, and public services.

Population Projections

- Comp Plan is a 20-year plan (with periodic updates)
- Estimated Albemarle County's population will be ~143,379 in 2044, an addition of ~31,000 community members compared with 2020
- From 2010 to 2020, Albemarle County's population increased by about 13.6%
 - Some surrounding localities grew at a similar rate: Greene County 11.7%; Louisa County 13.4%
 - While other surrounding localities grew at a slower rate (Orange County 8.3%) or lost population (Buckingham County -1.9%)

Big Ideas. Planning for an Equitable and Resilient Community

Draft Big Ideas were developed based on community input heard to date; Planning Commission feedback; Goals in the current (2015) Comp Plan; research of other localities; and American Planning Association (APA) best practices.

BIG IDEA / A GREEN & RESILIENT COMMUNITY

WHAT IS IT?

- Healthy and whole ecosystems with protected and intact waterways, water supply resources, forests, and other natural resources
- A Rural Area with protected farms and natural areas
- Sustainable and livable Development Areas with mixed use neighborhoods
- Preserved and valued historic, scenic, cultural, and archaeological resources
- A carbon-neutral community that is resilient against impacts of climate change

HOW DO WE GET THERE?

- Protect and enhance natural resources, especially tree canopies as natural carbon sinks and water supply watersheds
- Encourage regenerative and sustainable agriculture practices
- Continue identifying, interpreting, and protecting cultural and historic resources
- Promote sustainable land use and development practices such as compact, mixed-use development, and energyefficient design





















BIG IDEA / A WELCOMING & EQUITABLE COMMUNITY

WHAT IS IT?

- Equal opportunity for current and future community members to reach their potential for wellbeing and quality of life
- Housing that is accessible and affordable to all income levels
- Inclusive neighborhoods with mixed uses and a variety of housing types
- A range of services, including schools, recreation, health care and other needs for daily life, that is equitably distributed to all communities and income groups
- An informed and engaged community with a variety of opportunities to participate in civic life

HOW DO WE GET THERE?

- Encouraging an increased variety of housing types that are affordable and are equitably distributed with access to transportation and community facilities
- Ensuring that new housing, especially infill development, is appropriately scaled to surrounding neighborhoods
- Locating higher density development strategically where access and services are already located or planned, including encouraging redevelopment over new "greenfield" development
- Ensuring an equitable distribution of services, resources, and amenities
- Continuing to improve accessibility and transparency of local government process, information, and community engagement opportunities

WHAT IS IT?

- A community with safe, affordable and multimodal transportation options for all
- A network of trails and parks, along with connected wildlife corridors and stream networks
- Transportation and land use patterns that are resourceefficient, and reduce pollution and greenhouse gas emissions

HOW DO WE GET THERE?

- Promote the development of integrated and cohesive neighborhoods with easy and safe access to jobs, services and recreation
- Increase bicycle, pedestrian and transit options in both Development Areas and Rural Area
- Ensure connectivity of natural corridors in the Rural Area and connected green spaces and parks in existing and new neighborhoods
- Coordinate with adjacent and nearby localities for regional transportation opportunities

eWaste - Registration is required (Space is limited)

Rivanna Solid Waste Authority's Free disposal of electronic waste for residents of Albemarle County & City of Charlottesville only -

- No commercial participation.
- Only electronic waste will be accepted: Computer systems and accessories, printers, copies, scanners, fax machines, VCRs, camcorders, stereos, and televisions.
- No more than two (2) tube-style TVs or monitors per person.
- No more than ten (10) total items, per person.
- Please sign up for a time window and you must bring your ticket at the time you drop off eWaste items on September 17th. Registration Link Here

Residential Household Hazardous Waste (HHW) Days September 23rd and September 24th (9AM to 2PM only)

HHW collections are free only to residents of Albemarle County, Charlottesville, and Town of Scottsville, and available to Nelson County residents who obtain a voucher from Nelson County government.

Each year the RSWA holds a larger scale household hazardous waste collection day and accepts additional household hazardous substances and ensures that they are properly categorized and directed to a permitted offsite hazardous substance management location. The materials accepted on these days include:

- Acids
- Adhesives
- Antifreeze
- Batteries
- · CELe
- Floor and furniture polish
- Fluorescent tubes

- Gasoline
- Household deaners
- Kerosene
- Motor oil
- Paint and paint-related products & solvents
- Pesticides
